
# Flossbach von Storch -Global Quality - F<sup>2</sup>

## INVESTMENT STRATEGY


Flossbach von Storch - Global Quality is a global equity fund with an active, focussed investment approach. The focus is on long-term holdings in companies (real value concept), not short-term speculation. We therefore focus on the quality of the company, which is determined by the strength and predictability of the expected earnings performance. We value a strong and sustainable competitive position, a healthy balance sheet, attractive target markets and management with integrity and competence. High-quality companies tend to have above-average returns on invested capital and strong resilience to adverse developments. All investment decisions are based on a sound assessment of quality and valuation. We understand risk as an economic dimension, i.e. the danger of a permanent loss of capital as opposed to short-term fluctuations. Other in-house valuation models include ESG issues, engagement, and voting. In addition, exclusion criteria defined within the framework of the Sub-Fund's investment policy are taken into account.

The Sub-Fund is actively managed. The portfolio is composed by the fund manager exclusively in accordance with the criteria defined in the investment policy, reviewed regularly and adjusted if necessary. The performance of the Sub-Fund is compared using the MSCI World Net Total Return Index as a benchmark. The fund manager is not linked to the index at any time when making investment decisions and the portfolio composition. Therefore, the performance of the Sub-Fund may differ significantly from the benchmark shown. The Sub-Fund is categorized as an Article 8 product under the Disclosure Regulation (EU) 2019/2088 (SFDR). # MONTHLY COMMENTARY

May was once again characterised by trade policy stimuli from the US government. A 90-day tariff reduction between the USA and China and the postponement of a new tariff threat to the European Union eased tensions on the equity markets. The global MSCI World gained 6.1% in May (calculated in euros and including dividends) and was able to fully recover the losses since 2 April, when President Donald Trump announced comprehensive tariffs on Liberation Day. Market participants seem to be betting that Trump will always cave in before his policies cause too much damage to the real economy in view of the numerous U-turns in recent weeks. Currently, it does not appear that companies are putting the brakes on long-term investments despite the uncertainties and that economic activity is slowing down significantly. However, things have by no means quietened down on the government's economic stimulus front. Towards the end of the month, the focus shifted to the USA's escalating national debt. Trump's tax reform was passed by the House of Representatives and, if approved by the Senate, is likely to represent a (further) burden on the US budget. However, the increased nervousness on the bond market was unable to dampen the mood on the equity market on a sustained basis. In the portfolio, the largest positive value contributions in May came from three US companies: software and cloud provider Microsoft, manufacturer of cables, connectors and sensors Amphenol and animal diagnostics provider Idexx Laboratories. Negative value contributions were made by the shares of US service provider for the recovery of accident vehicles Copart, US conglomerate Berkshire Hathaway and Danish medical technology group Coloplast. At Berkshire Hathaway, 94-year-old CEO Warren Buffett announced that he would be handing over the reins to his long-designated successor Greg Abel at the end of the year. Coloplast had to reduce its profit forecast for the current year at the start of May, which also cost CEO Kristian Villumsen his job. The Chair of the Supervisory Board and former CEO Lars Rasmussen has taken over the position until a new CEO is found. In view of the investments made in recent years, the Supervisory Board was dissatisfied with the growth realised and is hoping for stronger impetus under new leadership. Even though management changes always entail risks, in our opinion the opportunities outweigh the risks in view of the company's strong fundamentals and the lower valuation of the share.
