
Flossbach von Storch -Global Quality - R²

INVESTMENT STRATEGY

Flossbach von Storch - Global Quality is a global equity fund with an active, focussed investment approach. The focus is on long-term holdings in companies (real value concept), not short-term speculation. We therefore focus on the quality of the company, which is determined by the strength and predictability of the expected earnings performance. We value a strong and sustainable competitive position, a healthy balance sheet, attractive target markets and management with integrity and competence. High-quality companies tend to have above-average returns on invested capital and strong resilience to adverse developments. All investment decisions are based on a sound assessment of quality and valuation. We understand risk as an economic dimension, i.e. the danger of a permanent loss of capital as opposed to short-term fluctuations. Other in-house valuation models include ESG issues, engagement, and voting. In addition, exclusion criteria defined within the framework of the Sub-Fund's investment policy are taken into account.

The Sub-Fund is actively managed. The portfolio is composed by the fund manager exclusively in accordance with the criteria defined in the investment policy, reviewed regularly and adjusted if necessary. The performance of the Sub-Fund is compared using the MSCI World Net Total Return Index as a benchmark. The fund manager is not linked to the index at any time when making investment decisions and the portfolio composition. Therefore, the performance of the Sub-Fund may differ significantly from the benchmark shown. The Sub-Fund is categorized as an Article 8 product under the Disclosure Regulation (EU) 2019/2088 (SFDR). MONTHLY COMMENTARY

The recovery of the US equity market continued in June, driven primarily by shares in large technology companies. The broad S&P 500 index rose by around 5% over the month and reached a new all-time high. However, this was only in the local currency, the US dollar, which continued to depreciate against the euro over the course of the month, losing almost 4%. The ongoing discussion surrounding US Federal Reserve Chair Jerome Powell, who was once again loudly criticised by US President Donald Trump, is likely to have played a role in this. Trump wants significant interest-rate cuts in order to stimulate the economy. Powell, on the other hand, has stated that he wants to wait and see due to the upside risks to inflation posed by Trump's tariff increases. In any case, the exchange rate (1.18 US dollars for one euro at the end of the month) reached its highest level in four years. This reduced the profits of European investors in the US equity market. There was also a significant divergence in the market: while the information technology and communication services sectors recorded significant gains amid renewed euphoria surrounding artificial intelligence, the shares of more defensive companies in the consumer staples and healthcare sectors lost value. This divergence could also be observed regionally: the broad European Stoxx 600 index lost around 1% over the course of the month. In terms of individual stocks, the biggest positive value contributions in June came from our holdings in US semiconductor supplier Applied Materials, US software provider Microsoft and US retailer Dollar General. Dollar General reported figures for the past quarter that showed signs of continued stabilisation in its business performance, which had recently entered difficult waters. The company was able to increase its sales by 5% year-onyear and slightly improve its margin for the first time after several quarters characterised by headwinds. The largest negative value contributions came from our investments in US conglomerate Berkshire Hathaway, German manufacturer of fragrances and flavourings Symrise and US consulting company Accenture. Accenture also reported quarterly figures, which basically painted a healthy picture with an 8% increase in sales and a slight year-on-year improvement in margins. However, the fact that incoming orders for new mandates fell by 6% year-on-year led to discussions as to whether client demand could weaken more significantly in the coming quarters.





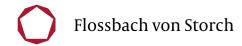
