
# Flossbach von Storch -Global Quality - R<sup>2</sup>

#### INVESTMENT STRATEGY

Flossbach von Storch - Global Quality is a globally diversified equity fund with an active and focused investment approach. At least 60 per cent of the Fund's assets are invested directly in equities and equity funds. The investment focus is on first-class, highly capitalised business models that are growing at an above-average rate and reliably, are highly profitable and stable, and are led by entrepreneurial management teams. The quality assessment of the business models and the weighing of the risk-reward ratio within the framework of the company valuation are decisive for every investment decision. The fund management pursues a long-term investment horizon and understands risk as an economic dimension. As a rule, investments are made in a maximum of 50 companies. Other in-house valuation models include ESG issues, engagement, and voting. In addition, exclusion criteria defined within the framework of the Sub-Fund's investment policy are taken into account. The Sub-Fund is actively managed. The portfolio is composed by the fund manager exclusively in accordance with the criteria defined in the investment policy, reviewed regularly and adjusted if necessary. The performance of the Sub-Fund is compared using the MSCI World Net Total Return Index as a benchmark. The fund manager is not linked to the index at any time when making investment decisions and the portfolio composition. Therefore, the performance of the Sub-Fund may differ significantly from the benchmark shown. The Sub-Fund is classified as an Article 8 product under the Disclosure Regulation (EU) 2019/2088 (SFDR). 

# MONTHLY COMMENTARY

The capital markets were dominated in November by the election of Donald Trump as the next US president. The clarity of the election result is likely to have brought relief to US equity markets. Not only did the clarity of the election victory reduce the risk of civil unrest similar to the storming of the Capitol in January 2021, but the incoming US president will now have a Republican majority in both chambers of Congress. In addition to the prospect of further tax breaks – for example, on overtime worked – and the reduction of regulatory requirements, this clarity has contributed to a celebratory mood on the stock market and led to new record levels for the US S&P 500 equity market index, which ended the month at over 6,000 points for the first time. However, the performance beneath the surface was quite divergent and fluctuated with news of personnel decisions regarding the future cabinet and further statements by the future president. Uncertainty about the exact impact on the economy and different industries remains high. Nevertheless, US equities were clearly in favour of many investors and, measured against the leading indices, European equities lagged well behind in terms of performance. This was further exacerbated by the performance of the US dollar, which appreciated by almost three per cent against the euro in November. The dynamics described were reflected in the portfolio. Overall, the unit price increased encouragingly. The three largest positive value contributions at an individual stock level came from three US-based companies: broker and asset manager Charles Schwab, online retailer and cloud provider Amazon, and conglomerate Berkshire Hathaway. Among the few holdings with negative value contributions in the month under review, three European companies were at the forefront: French industrial goods manufacturer Legrand, pharmaceutical group Roche, and consumer goods manufacturer Nestlé, the latter two based in Switzerland.

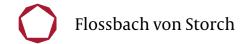

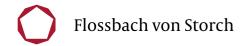
