## WHAT IS THIS PRODUCT?

**Type:** The product is a share class of the Flossbach von Storch III SICAV - Multiple Opportunities II Feeder sub-fund, which is part of Flossbach von Storch III SICAV (the "Umbrella Fund"), an open-ended investment company with variable capital (société d'investissement à capital variable – SICAV) that has been established in the form of an umbrella fund and is subject to Part I of the Luxembourg Law of 17 December 2010 (Law of 2010), as amended, and thus qualifies as a UCITS. The assets and liabilities of each sub-fund are segregated by law.

**Term:** The product has an unlimited term. Notwithstanding this, the product may at any time be liquidated by the Management Company. As a rule, investors can redeem their units on any Luxembourg banking day except 24 and 31 December. The manufacturer may suspend redemption if exceptional circumstances make this appear necessary when investor interests are taken into account.

### Objectives:

The objective of the investment policy of the Flossbach von Storch III SICAV - Multiple Opportunities II Feeder (the "sub-fund"), as a feeder UCITS, is to reflect to the greatest extent possible the performance of the Flossbach von Storch - Multiple Opportunities II (unit class MT) sub-fund ("Master UCITS"), a legally dependent investment fund in the form of an umbrella fund in accordance with Section 2 of the Law of 17 December 2010. The master UCITS is managed by Flossbach von Storch Invest S.A. The sub-fund perpetually invests at least 85 per cent of its net assets in units of the master UCITS. The sub-fund is therefore a feeder UCITS as defined in Article 77 of the Law of 17 December 2010. Investment in cash and cash equivalents is limited to 15 per cent of the net assets of the sub-fund. Units in the master UCITS may be acquired up to 100 per cent of the net assets of the sub-fund. In view of the aforementioned investment limits, the sub-fund is therefore not eligible for the target fund. The use of derived financial instruments ("derivatives") or other techniques and instruments is not permitted. The objective of the investment policy of the master UCITS is to achieve reasonable growth in the sub-fund's currency while taking into consideration the risk involved for the investors. The investment strategy is defined based on fundamental analyses of the global financial markets. The master UCITS is actively managed. No index is used for comparison purposes. Depending on the market situation and appraisal by the fund management, the master UCITS generally has the possibility to invest in equities, bonds, money market instruments, certificates, other structured products (e.g. reverse convertible bonds, warrant-linked bonds, convertible bonds), target funds, derivatives, cash and fixed-term deposits without restriction. The certificates are for legally permitted underlying instruments, such as equities, bonds, investment fund units, financial indices and currencies. At least 25 per cent of the net assets of the sub-fund are continuously invested in equity participations. The master UCITS may invest up to 20 per cent of the net sub-fund assets indirectly in precious metals (gold, silver, platinum). In the interests of risk diversification, no more than 10 per cent of the sub-fund's net assets may be invested indirectly in one precious metal. Units in UCITS or other UCI ("target funds") may be acquired up to a maximum limit of 10 per cent of the masterfund's net assets. The use of derived financial instruments ("derivatives") is planned in order to achieve the aforementioned investment objectives, as well as for investment and hedging purposes. The current sales prospectus provides detailed information on the above and other investment opportunities available to the master UCITS. This sub-fund may not be suitable for investors that want to withdraw their capital from the sub-fund within a period of 5 years. This share class distributes the income it generates to investors. The Master-UCITS promotes environmental and social characteristics as defined in Article 8 of Regulation (EU) 2019/2088. 

## WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?



### Summary Risk Indicator

The summary risk indicator ("SRI") is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as class 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the capacity of the fund to pay you.



The risk indicator assumes you keep the product for a minimum of 5 Years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

## WHAT HAPPENS IF FLOSSBACH VON STORCH INVEST S.A. IS UNABLE TO PAY OUT?

The sub-fund assets are segregated from the assets of the Management Company. The Depositary is responsible for holding the assets of the fund in safekeeping. If the Management Company defaults, it will have no direct financial effect on the sub-fund. In addition, the sub-fund assets are segregated from the assets of the Depositary, which reduces the risk of the sub-fund suffering a loss if the Depositary defaults. There is no investor compensation or guarantee scheme if the Management Company or the Depositary defaults.

## WHAT ARE THE COSTS?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

### Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods:

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

## HOW LONG SHOULD I HOLD IT AND CAN I TAKE MY MONEY OUT EARLY?

**Recommended minimum holding period: 5 Years**

The recommended holding period for the sub-fund is 5 years, as the sub-fund invests for the long term. Investors can sell their shares upon demand on any valuation day (as defined in the sales prospectus).
