WHAT IS THIS PRODUCT?

Type: The product is a share class of the Flossbach von Storch - Dividend sub-fund, which is part of the Flossbach von Storch fund, a Luxembourg investment fund (fonds commun de placement – FCP) that has been established in the form of an umbrella fund and is subject to Part I of the Luxembourg Law of 17 December 2010 (Law of 2010), as amended, and thus qualifies as a UCITS. The assets and liabilities of each sub-fund are segregated by law. **Term:** The product has an unlimited term. Notwithstanding this, the product may at any time be liquidated by the Management Company. As a rule, investors can redeem their units on any Luxembourg banking day except 24 and 31 December. The manufacturer may suspend redemption if exceptional circumstances make this appear necessary when investor interests are taken into account.

Objectives:

The objective of the investment policy of the Flossbach von Storch - Dividend (the "sub-fund") is to distribute a reasonable amount of annual income each year and to achieve reasonable asset growth in line with the risk levels, taking into consideration the risk involved for the investors. The focus of the investment strategy is on generating recurring and increasing distributions and achieving an adequate increase in value over time, which is why companies with attractive dividend profiles in the form of a secure dividend with further potential for growth are the focus of the investment philosophy. A better-than-average ability to withstand crises and sustained profit growth with an appropriate distribution ratio and a solid financial structure are particularly important target attributes for companies to have. The sub-fund is actively managed. No index is used for comparison purposes. At least 80 per cent of the sub-fund's net assets are invested in equities. The fund may additionally invest in equity certificates, equity index certificates, bonds, fixed-term deposits and target funds. The Fund may invest globally, and there are no regional restrictions. Units in UCITS or other UCI ("target funds") are not acquired. The use of derived financial instruments ("derivatives") is planned in order to achieve the aforementioned investment objectives, as well as for investment and hedging purposes. The current sales prospectus provides detailed information on the above and other investment opportunities available to the sub-fund. This sub-fund may not be suitable for investors that want to withdraw their capital from the sub-fund within a period of 5 years. This unit class does not distribute any income to investors, but instead reinvests it. The sub-fund assets are segregated from the assets of the Management Company. The Depositary is responsible for holding the assets of the fund in safekeeping. If the Management Company defaults, it will have no direct financial effect on the sub-fund. In addition, the sub-fund assets are segregated from the assets of the Depositary, which reduces the risk of the sub-fund suffering a loss if the Depositary defaults. There is no investor compensation or guarantee scheme if the Management Company or the Depositary defaults.
