## WHAT IS THIS PRODUCT?

**Type:** The product is a share class of the Flossbach von Storch SICAV - Multiple Opportunities sub-fund, which is part of Flossbach von Storch SICAV (the "Umbrella Fund"), an open-ended investment company with variable capital (société d'investissement à capital variable – SICAV) that has been established in the form of an umbrella fund and is subject to Part II of the Luxembourg Law of 17 December 2010 (Law of 2010), as amended, and thus qualifies as an alternative investment fund. The assets and liabilities of each sub-fund are segregated by law.

**Term:** The product has an unlimited term. Notwithstanding this, the product may at any time be liquidated by the Management Company. As a rule, shares in the Fund can be returned on any valuation day. The manufacturer may suspend redemption if exceptional circumstances make this appear necessary when investor interests are taken into account.

### Objectives:

The objective of the investment policy of the Flossbach von Storch SICAV – Multiple Opportunities (the "sub-fund") is aimed at achieving reasonable growth in the sub-fund's currency while taking into consideration the risk involved for the investors. The investment strategy is defined based on fundamental analyses of the global financial markets. The sub-fund is actively managed. No index is used for comparison purposes.

The sub-fund invests in accordance with the principle of risk diversification worldwide in equities, money market instruments, certificates and bonds of all kinds, including zero coupon bonds, variable interest securities and structured products (e.g. reverse convertible bonds, warrant-linked bonds and convertible bonds) that are listed on a stock exchange or traded on another regulated market, with the equity allocation a maximum of 100% of the net assets of the sub-fund. The sub-fund may also acquire all types of target funds permitted under its rules as part of its active management. In addition, at least 25% of the net assets of the sub-fund are continuously invested in equity participations. Up to 15% of the net assets of the sub-fund may be invested directly in (physical) gold. In addition, up to 10% of the assets of a sub-fund may be indirectly invested (e.g. using certificates, gold bullion securities etc.) in gold and other precious metals. The use of derived financial instruments ("derivatives") is planned in order to achieve the aforementioned investment objectives, as well as for investment and hedging purposes. The current sales prospectus provides detailed information on the above and other investment opportunities available to the sub-fund. As a rule, investors can redeem their shares on any Luxembourg banking day except 24 and 31 December. Share redemption can be suspended if exceptional circumstances make this appear necessary when investor interests are taken into account. This sub-fund may not be suitable for investors that want to withdraw their capital from the sub-fund within a period of 5 years. This share class distributes the income it generates to investors.

The sub-fund promotes environmental and social characteristics as defined in Article 8 of Regulation (EU) 2019/2088. Flossbach von Storch follows a holistic sustainability approach across the group: As a long-term investor, Flossbach von Storch attaches importance to companies dealing responsibly with their environmental and social footprint and actively counteracting negative impacts of their activities.

### Intended Retail Investor:

The product is intended for all types of investor pursuing the aim of asset formation and/or asset optimisation and planning to invest in the medium to long term. ## WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?



### Summary Risk Indicator

The summary risk indicator ("SRI") is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as class 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the capacity of the fund to pay you.



The risk indicator assumes you keep the product for a minimum of 5 Years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

## WHAT HAPPENS IF FLOSSBACH VON STORCH INVEST S.A. IS UNABLE TO PAY OUT?

The sub-fund assets are segregated from the assets of the Management Company. The Depositary is responsible for holding the assets of the fund in safekeeping. If the Management Company defaults, it will have no direct financial effect on the sub-fund. In addition, the sub-fund assets are segregated from the assets of the Depositary, which reduces the risk of the sub-fund suffering a loss if the Depositary defaults. There is no investor compensation or guarantee scheme if the Management Company or the Depositary defaults.

## WHAT ARE THE COSTS?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

### Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods:

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

## HOW LONG SHOULD I HOLD IT AND CAN I TAKE MY MONEY OUT EARLY?

**Recommended minimum holding period: 5 Years**

The recommended holding period for the sub-fund is 5 years, as the sub-fund invests for the long term. Investors can sell their shares upon demand on any valuation day (as defined in the sales prospectus).
