WHAT IS THIS PRODUCT?

Type: The product is a share class of the Flossbach von Storch SICAV - Multiple Opportunities sub-fund, which is part of Flossbach von Storch SICAV (the "Umbrella Fund"), an open-ended investment company with variable capital (société d'investissement à capital variable – SICAV) that has been established in the form of an umbrella fund and is subject to Part II of the Luxembourg Law of 17 December 2010 (Law of 2010), as amended, and thus qualifies as an alternative investment fund. The assets and liabilities of each sub-fund are segregated by law.

Term: The product has an unlimited term. Notwithstanding this, the product may at any time be liquidated by the Management Company. As a rule, investors can redeem their units on any Luxembourg banking day except 24 and 31 December. The manufacturer may suspend redemption if exceptional circumstances make this appear necessary when investor interests are taken into account.

Objectives:

The investment objective of Flossbach von Storch SICAV - Multiple Opportunities ('sub-fund') is to achieve reasonable growth in the sub-fund's currency while taking into consideration the risk involved for the investors. The investment strategy is defined based on fundamental analyses of the global financial markets. The sub-fund is actively managed. No index is used for comparison purposes. Depending on the market situation and appraisal by the fund management, the sub-fund generally has the possibility to invest in shares, money market instruments, certificates and bonds of all types, including zero-coupon bonds, variable-rate securities and structured products (e.g. reverse convertible bonds, warrant-linked bonds and convertible bonds), target fund units, cash and fixed-term deposits. Furthermore, at least 25% of the sub-fund's net assets shall be continuously invested in equity interests. With respect to the target funds held by the fund (including ETFs) as well as certificates and derivatives on commodities, commodity indices and baskets, it is agreed that no physical deliveries of commodities or goods shall take place on behalf of the fund. This does not apply to deliveries of gold. Up to 15% of the sub-fund's net assets may be invested directly (physically) in gold. In addition, the respective sub-fund may invest up to 10% of its net assets indirectly (e.g. through certificates, gold bullion securities etc.) in gold and other precious metals, provided that the total (direct and indirect) investment in gold never exceeds 25% of the sub-fund's net assets. The use of derived financial instruments ("derivatives") is permitted in order to achieve the aforementioned investment objectives, as well as for investment and hedging purposes. Detailed information on the aforementioned and, where applicable, other investment options of the sub-fund can be found in the currently valid Sales Prospectus. This sub-fund may not be suitable for investors who wish to withdraw their money from the sub-fund within a period of 5 years. This share class distributes the income it generates to investors. The sub-fund promotes environmental or social characteristics within the meaning of Article 8 of Regulation (EU) 2019/2088. Flossbach von Storch follows a holistic sustainability approach throughout the Group: As a long-term investor, Flossbach von Storch attaches great importance to companies managing their environmental and social footprint responsibly and actively countering the negative effects of their activities.

Intended Retail Investor:

The product is intended for all types of investor pursuing the aim of asset formation and/or asset optimisation and planning to invest in the medium to long term. WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

Summary Risk Indicator

We have classified this product as class 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the capacity of the fund to pay you.

WHAT HAPPENS IF FLOSSBACH VON STORCH INVEST S.A. IS UNABLE TO PAY OUT?

The sub-fund assets are segregated from the assets of the Management Company. The Depositary is responsible for holding the assets of the fund in safekeeping. If the Management Company defaults, it will have no direct financial effect on the sub-fund. In addition, the sub-fund assets are segregated from the assets of the Depositary, which reduces the risk of the sub-fund suffering a loss if the Depositary defaults. There is no investor compensation or guarantee scheme if the Management Company or the Depositary defaults.

WHAT ARE THE COSTS?

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. HOW LONG SHOULD I HOLD IT AND CAN I TAKE MY MONEY OUT EARLY?

Recommended minimum holding period: 5 Years

The recommended holding period for the sub-fund is 5 years, as the sub-fund invests for the long term. Investors can sell their shares upon demand on any valuation day (as defined in the sales prospectus).
